Annual Congregational Meeting Minutes from November 20, 2022

The MCC Richmond Congregational Meeting was held in person in the Celebration Hall on Sunday, November 20, 2022. The meeting was called to order at 1:05 p.m. by Vice Moderator Shari Drees. Mark Harrell opened the meeting in prayer.

Shari Drees called on Philip Adams, Church Clerk to certify the quorum. Philip responded that 29 members had been checked in and that exceeded the requirement of 20% of the membership or 22 members. (During the meeting, an additional two members came in after the quorum was called for a grand total of 31.) Church Clerk, Philip Adams introduced the Board members who were present - Shari Drees, Vice Moderator; John Poarch, Treasurer, Al Canary, Director; M.J. Simmons, Director; and Philip Adams, Clerk. Tia Meek, Director was unable to attend. Philip Adams explained that there was no Parliamentarian for the meeting, but that he had a copy of the Bylaws and would call for assistance if needed.

Philip Adams gave a brief summary of the agenda for the meeting. Shari Drees asked for a motion to approve the agenda which was made by Tigger Grosvenor and seconded by Georgia Thweatt-Johnson. The motion was approved on a voice vote with no negative votes.

Philip Adams indicated that the minutes from the 2021 Congregational Meeting had been included with the packet. Philip Adams asked for a motion to approve the minutes which was made by John Pall and seconded by Ginny Loving. The motion was approved on a voice vote with no negative votes or abstentions. Philip Adams called attention to the written reports that had been included in the membership packet. He noted some additional information for the Vicky Hester Food Pantry as Anthem had provided socks and blankets for all the patrons of the food pantry and Altrusa International had provided turkeys for 12 Thanksgiving baskets. Shari Drees presented a brief summary of her written report. John Poarch, Treasurer presented a brief year to date summary of the church financials through September 30, 2022.

Loretta Mountcastle presented the Nominating Committee Report. She mentioned that there were three candidates for two Board positions including Daniel Burgess Fehner, Catherine Pall, and Philip Adams. She mentioned that there was no candidate for the First Lay Delegate. She introduced John Pall as the candidate for the Second Lay Delegate and Les Quintana-Branch as the candidate for the Alternate Lay Delegate. Upon a motion by Loretta Mountcastle

and a second by Catherine Pall, the reports were accepted and approved. The motion was approved on a voice vote with no negative votes or abstentions. There was no Unfinished Business.

Under New Business, Shari Drees introduced John Poarch, Treasurer to present the budget. A couple of questions were asked and answered. Greg Nelson made the motion to accept the budget as presented and Les Quintana-Branch seconded. The budget was approved by a voice vote with no negative votes or abstentions.

All Board candidates were provided a brief opportunity to address the membership. Doug Ritcher and Lucas Maertin, as Friends of the Church were appointed to tally the votes. Ann Herbst collected the ballots. It was noted that the Board had the authority to appoint a Member to the First Lay Delegate position.

Daniel Burgess Fehner requested that the membership support Catherine Pall and Philip Adams for the two Board positions. The ballots were collected and tallied. Catherine Pall and Philip Adams were elected for 2-year terms; John Pall was elected as Second Lay Delegate and Les Quintana-Branch was elected as Alternate Lay Delegate.

Shari Drees directed attention to the election of two positions for the Nominating Committee. (In 2021, Carol Anderson explained that all members present held an initial vote by virtue of being a member in attendance. She recommended for individuals to second a nomination in order to provide names to serve for the vacant positions on the Nominating Committee. This procedure was followed again in 2022.)

Loretta Mountcastle seconded Tigger Grosvenor for the Nominating Committee. Tigger Grosvenor accepted the nomination. Loretta Mountcastle seconded Chuck Bateman for the Nominating Committee. Chuck Bateman accepted the nomination. Catherine Pall seconded John Pall for the Nominating Committee. John Pall accepted the nomination. Loretta Mountcastle seconded Kendall McKnight for the Nominating Committee. Kendall McKnight did not accept the nomination. The nominations were closed by consensus. Members were instructed to write down two names for the two positions on the Nominating Committee. Ballots were collected and tallied and Tigger Grosvenor and Chuck Bateman were elected.

Shari Drees led the discussion related to the proposed Bylaw Amendment to reduce the number of members on the Pastoral Search Committee to 6 (one Board member and 5 elected members) from 11. John Pall moved and Ginny Loving seconded the discussion on the Amendment. Shari Drees explained the Board's thinking on reducing the number of individuals on the Committee to help expedite the work of the Committee.

After some discussion and feedback mostly concerning leaving an even number on the Committee, Ginny Loving proposed an amendment to the Amendment as presented by the Board of Directors. She recommended that the Committee be reduced to seven members with 1 Board member and 6 elected members. Greg Nelson seconded the Amendment to the Bylaw Amendment. The Board agreed to the Amendment and ballots were changed, voted, and collected. Philip Adams noted that the Bylaws required 2/3 of the quorum to approve, and so a minimum of 21 votes were needed to approve the Amendment. The tally of the ballots indicated 29 in favor with 2 opposed and so, the Amendment was approved.

Ginny Loving announced the recipient of the Richard Pittenger Annual Music Award as Daniel Burgess Fehner for his volunteer efforts for the choir and supporting the Church Music Program.

Shari Drees announced the recipient of the Elaine German Volunteer of the Year Award. Carol Anderson was the recipient for her work with the Food Pantry, Sunday School and so many acts of service during the year in many capacities for the church. Carol Anderson was not in attendance and will be informed of this award.

No written comments were received from the Membership for further discussion. The floor was opened for comment and questions. There were a few comments and Thank-Yous to the Board. Outgoing Board members, Shari Drees and Tia Meek were thanked for their service to the Board. Georgia Thweatt-Johnson offered the closing prayer. Ginny Loving made a motion to adjourn the meeting. The motion was seconded by Sally Watkinson and approved by voice vote. The meeting was adjourned at 2:06 p.m.

Special Congregational Meeting Minutes

February 12, 2023

The Congregation met in person at the Church Celebration Hall on Sunday, February 12, 2023 immediately following the Potluck Luncheon. The sole purpose for the meeting was to elect a Pastoral Search Committee. The meeting was called to order at 12:38 p.m. by Rev. Gail Minnick who also provided the opening prayer. Philip Adams, Church Clerk was called on to call the membership roll. Following a couple of corrections and clarifications, it was determined that 36 out of 105 church members were present which met the quorum of 20% which would have been 21 members.

Rev. Gail Minnick had the Board of Directors and the elected Lay Representatives stand up to be recognized. Present were Catherine Pall, Vice Moderator; John Poarch, Treasurer; M.J. Simmons, Facilities; Al Canary, Member at Large; Danny Burgess, First Lay Delegate; and, Philip Adams, Church Clerk. Also recognized were John Pall, Second Lay Delegate and Les Quintana-Branch, Alternate Lay Delegate.

John Pall served as the Parliamentarian for the meeting. Rev. Gail Minnick shared a brief discussion of the hand out regarding the steps in the process for the new Committee. There was a time period for questions and answers. Following this open discussion, Rev. Gail Minnick asked for nominations to begin concerning filling the Committee. She noted that the nomination should be clearly made and that the person nominated should either accept or decline the nomination.

Tigger Grosvenor nominated Georgia Thweatt-Johnson who accepted the nomination.

Kendall McKnight nominated Leslie Nelson who accepted the nomination.

John Poarch nominated Les Quintana-Branch who accepted the nomination.

Greg Nelson nominated Ricki King who accepted the nomination.

Catherine Pall nominated Ginny Loving who accepted the nomination.

M.J. Simmons nominated Shari Drees who accepted the nomination.

Greg Nelson nominated Chuck Bateman who was not present, but upon the testimony of two witnesses aware of his interest, Chuck was considered a viable candidate.

Nona Drumheller self-nominated.

Loretta Mountcastle nominated John Pall who accepted the nomination.

Danny Burgess nominated Henry Quintana-Branch who accepted the nomination.

Arthur Dewey self-nominated.

Chris Kopczynski nominated Loretta Mountcastle who declined the nomination.

Ricki King nominated Mo Southall who accepted the nomination.

Nona Drumheller nominated Stepney Setzer-Storrs who declined the nomination.

M.J. Simmons nominated Chris Kopczynski who declined the nomination.

Rev. Gail Minnick asked for any further nominations. Hearing none, she declared the nominations complete and asked Anne Herbst, Friend of the Church to serve as the ballot counter. Anne was provided a tally sheet and went to another room to tabulate the votes.

The results of the voting were announced with the Committee consisting of John Pall, Ricki King, Shari Drees, Leslie Nelson, Ginny Loving and Chuck Bateman. M.J. Simmons will serve as the Board representative.

Rev. Gail Minnick opened the floor for comments from the Board and thanks and appreciation were extended to all of those who considered running and to the Committee who will serve. Rev. Gail Minnick imparted a blessing to the Committee members who were present and was joined by the congregational members who participated in the blessing by raising their hands to the Committee.

The meeting was declared adjourned at 1:25 p.m.

Interim Gap Pastor's Report Congregational Meeting November 1, 2023

Dear Members and Friends of MCC Richmond,

This has been an exciting and wonderful year. You will receive many reports and updates to keep you informed; however, I would like to provide you with a high-level overview from my perspective.

Since I have been here, I have witnessed growth in our membership, greater stability in finances, and exciting changes in our worship experiences and our administrative processes. There are new faces coming every week, and I find that to be very encouraging.

I do not want to duplicate information from the other ministry leaders, but there are some important items to note. For example, the ceiling project has been completed (although we still have some debt to close this out), we hired a new amazing pianist, and an administrative assistant (stop by the office Monday – Thursday to say "hi"). The Pastoral Search Team is making excellent progress and will soon launch our effort. Our Sunday School and Ministry of Care teams are growing and reaching people in remarkable ways. We have returned to having potlucks and are still providing the VHFP and bread ministries to those in need. Our Good Neighbor Fund is up and operational and we have directly helped 5 families since May.

In celebration the Fashion Show was huge fun and successful and we celebrated over 30 in our building and 45 years in ministry during the month of June. What an anniversary!

We have expanded our worship participation with some new faces and experimented with new worship elements and styles to keep things fresh and new. Our music ministry is still incredible, the Spirits of Joy keep getting better, and the Joyful Ringers are a blessing and presented their first concert.

Looking ahead, we will be looking at how to make our facility more available to the wider public in order to generate income from this fabulous asset. And even though our safety program had a slow start, things are heating up and there will be new information coming soon.

We bought some new hardware and software to keep our technical capabilities current and have a vibrant and engaged technical and communication ministry. And we will be participating in the FIRST Habitat for Humanity PRIDE build project on November 11th.

I am extremely blessed by this church and this ministry, and I look forward to more good things in 2024. MCC Richmond you are AWESOME!

Vicky Hester Food Pantry

December 2022 to November 2023

MCC Richmond, you should be proud and amazed at this vital ministry serving the underhoused, senior and food insecure community!

Through your generosity and the generosity of Vicky Hester, for whom the ministry is named, we have served over 3600 meals and provided over 32,000 lbs. of groceries! That is right 3600 meals and 32,000 lbs., of food! In addition, the Clothes Closet and Toiletry Center run by Tigger Grosvenor has provided all types of critical seasonal clothing items as well as personal hygiene items essential for those living outside. Yes, God is Good!!!

The Vicky Hester Food Pantry (VHFP), as well as all other ministries like ours, has seen dramatic increases in the number of individuals served. The VHFP average number of clients served has increased to greater than 75 per week. All of this is happening because of your commitment and vision as well as the dedicated group of 20 volunteers who come to set up tables, prepare meals, stock grocery items, sort clothing and serve meals! Smiles and love are always on the menu. Our clients are always amazed at the warmth and love shared!

An exciting opportunity arose for us to partner with a group called <u>Just Compassion</u>. They are primarily a non-profit providing much needed dental care to individuals who are underserved in rural Virginia, but because of the Line Dancing exposure for giving to the VHFP a dancer recommended that they contact us to provide a location to serve sandwiches once a month. On Subway Thursdays (the second Thursday of each month), Just Compassion delivers and serves 65 sandwiches!

And our partnerships don't end there! This past spring a group of 24 churches came together at First Baptist Church to form Faith United to address the needs of poverty and injustice in the greater Richmond Metropolitan area. We have already made connections and received donations of canned goods from churches who provide groceries! Eight different faith movements are working together to do what can be done in the areas of affordable housing, food insecurity and financial assistance. Sharing resources, ideas and a compassion for ministry!

Our partnership continues with Daily Planet and Virginia Public Health Department who each come to the VHFP once a month providing needed medical screenings, vaccines and resources. This month we will again partner with the Daily Planet/Anthem sponsored event to provide new socks and blankets. A van comes to

MCCRVA to hand out the items and we will serve soup and bread as in prior years. We will serve an anticipated 85-100 people.

This report would not be complete without just mentioning the folks who make this happen every single week (and please forgive me if I missed your name). The first names of those who are a part of this incredible ministry: Rev Georgia, Chuck, Leslie (our wonderful buyer), Tigger, Carla, Daryl, Chris, Richard, Al, David, Jo Ann, Faye, Leia, Don, Ron, Sue, Jack, Susan, Lucas, Helena, Abby and YOU! Please consider donating, volunteering and supporting this compassion ministry!

Bread Ministry Report

The amount always varies, but there always seems to be enough to go around.

Ministry of Care Report

Vision: To practice the principles of a loving all-inclusive God through caring and serving our church family, and spiritual community through the life and ministry of MCC Richmond. The Ministry of Congregational Care is built on the teachings of Jesus words in Mathew 25: 40. "In as much as you have done it to the least of these, you have done it unto me."

Mission: To be a resource of hope and channel of prayer in time of need, to extend hospitality, hope and worship

beyond the walls of the sanctuary, and to provide the Holy Meal (Eucharist) to those unable to come to the table.

Schedule: The MOCC meets every Thursday from 8 pm to 8:45 pm via zoom and conference call, and one to two times yearly in person for training to explore, develop, implement, and update ministry skills and techniques that support the spiritual growth and wellbeing of our church. Meetings consist of open prayer, team check-in, assigned devotional or meditative reading. Prayers and Praise reports are read openly by the team. Prayers are received by phone and written request. A ministry activity report is presented as needed with the of number of home, hospital visits as well as the number of cards and letters sent out to the fellowship and friends of the fellowship, and any congregants being transported to medical appointments. Closing remarks and prayer completed the meeting. Current Services: MOCC Wednesday noon prayer service postponed due to sanctuary repairs resumption date TBD, Dedicated Prayer Hot line: prayer, monitored by ministerial staff, and transportation service for members to attend church, and medical appointments.

Centering Community Report

Centering Community Meditation and Prayer (CCM&P) will be entering into its fifth year of continuous in person gathering on Mondays at 5:30 pm, in Church Community Center. Attendees are invited share in dialogue, meditation, and prayer time; this is a time of connection and reflection, open to all, that is centered on the foundation of conscious presence, and spirituality through open practices of contemplation, mindfulness, and scared silence.

One of our primary goals is to assist in the ongoing mission of supporting a safe space for individuals where they are welcomed with openness, and they are supported in love and encouraged in wellness through the gift of sharing time and being present. We desire this to be a time of uplifting individually, encouraging practices of transparency, and authenticity that will be carried forward throughout the week.

The group strives for shared leadership by all in attendance, with facilitation provided by Reverend Georgia Thweatt-Johnson. The meeting opens with a ten-to-fifteen-minute welcome, greeting and catching up period. This opening time includes dialogue around personal life experiences, teachings on basic contemplative, and varied meditative practices and applicable reading material. Followed by a twenty-to-thirty-minute silent meditation, and centering practice. Our gathering concludes with a period of reflective dialogue on the experience.

2023 offered some challenges as well as some opportunities, it was decided that CCM&P would not continue with its zoom service due to technical issues, and lack of virtual attendance. Most of our consistent attendees have been groups of four to seven weekly. As states earlier, Centering Community Meditation & Prayer is not about any particular philosophy, teachings, or meditation practices; rather it is about being-ness, finding a space of peace, harmony, and balance, where one can engage and practice a collective shared consciousness of love.

2024 goals for Centering Community Meditation & Prayer:

- Continuing to provide an open and safe space, for the opportunity, and time to explore, expand and expedience the presence of mind-fullness and gratitude. To be a place of connection and restoration for anyone who is seeking harmony and balance.
- All are welcome to come and celebrate with purposeful intention as we recognize every voice as valid and valuable. We are an open and affirming space and our shared humanity is expressed and honored in diverse ways.

Safety Committee Report

The Safety Committee began meeting in February 2023 over zoom to discuss the safety concerns of the church in the times that we now live in.

We have discussed several areas of importance since that time, including but not limited to:

- Building Safety and Security
- Active Shooter/ Dangerous Person Situations
- Knowing the special talents and certifications of members.

We have created a survey to assess the congregation's special skills and talents (ie CPR certification, specialty training etc.)

We have spent a lot of time in the last year trying to have a thorough inspection and assessment of the property.

We were also made aware of a grant through the Department of Homeland Security that could become available to us based on our security needs that will allow MCC Richmond to make needed improvements with no cost to us. In October a detective from the Richmond Police Department and an agent from Homeland Security came out and completed a comprehensive assessment of our grounds and both buildings. We are still awaiting that report to take next steps.

Facilities Report

2023, the year the restoration of our ceiling became a reality. It is the largest single repair done in our history at 2501 Park Avenue and I am so proud to be part of this loving, generous community, and its dedication to not only keeping the doors to our church open, but to continuously make this a more beautiful, better functioning home to all those who seek to be part of it!

It took a lot to restore the ceiling to its former glory. For almost three months scaffolding took up the entire Sanctuary, and Sunday services, as well as choir practice, were being held downstairs in the Celebration Hall. To accommodate this, the food pantry did some reorganizing and graciously adjusted their routine and set-up.

Thanks to the efforts of all who helped move the necessary equipment on "moving day", and extraordinary diligence from the Audio-Video team, services went on (practically) without a hitch, both in person and on-line.

On June 1st, David Polard and his team (who did an outstanding job) cleaned their last paintbrushes and packed up their final tools. The long-anticipated repair of the ceiling was finished. Just in time for our 45th anniversary celebration to take place upstairs in the Sanctuary.

A pristine ceiling notwithstanding, other matters needed attention:

- The door to the Sanctuary from the Sacristy needed a handle and got it.
- The HVAC system was making a terrible noise. Old Dominion Mechanical came and replaced the bearings, the rusted shaft, the sheave, and the bushing. All this to say they fixed it, and the terrible noise is gone!
- The elevator was inspected and found to be in good working order.
- The roof over the landing to the church received a much-needed repair and water now goes where it is supposed to go.
- The gutters to the church as well as the community center were cleaned.
- The doors from the hallway to the Sanctuary were repaired and adjusted, so they are operable again. (Still awaiting a paint touch up)
- The padlocks to the front and back gate, as well as the door to the basement of the Community Center were replaced and are now all keyed-alike.
- The "half-pew" that was in front in the sanctuary was relocated to the back, to make room for the Bell choir tables.

Projects currently in development:

- The Safety Committee is looking into the application of improved safety measures, in collaboration with the Richmond Police Department.
- A new banner for the front of the church is being designed and created.
- Remote access to the alarm panel in the community Center has been solicited.
